

2023 - 2024 School-Wide Parent and Family Engagement Policy

Part I: School-Wide Parent and Family Engagement Policy

Linwood Public Charter School receives Title I, Part A funds and must develop a School-Wide Parent and Family Engagement Policy. Part II: Policy Involvement

Linwood Public Charter School will convene an annual school-wide Title I meeting, every fall term and at convenient dates/times, to which all parents of participating children shall be invited and encouraged to attend. The purpose of the meeting will be to explain Title I, Part A program/requirements, describe parental and family engagement activities and parents' rights, and encourage parent involvement to improve students' academic performance. Parents will be notified of the meeting through parent newsletters, flyers, JCampus, Class DOJO, and the school's website.

Linwood Public Charter School will offer a flexible number of meetings to increase attendance, (e.g.: meetings in the early morning, late afternoon, and evening), and may provide, with funds provided under this part, transportation, childcare, or home visits, as such services relate to parent and family engagement. Meetings will be held virtually and/or face-to-face. The school will also use verbal and written communication methods.

Linwood Public Charter School will provide coordination, technical assistance, and other support to assist the school in planning and implementing effective parent and family engagement activities to improve student academic achievement and school performance. They will review suggestions/comments and act accordingly.

Part III: Share Responsibilities for High Student Academic Achievement

Linwood Public Charter School will develop jointly with parents and teachers a School-Parent Compact ANNUALLY. The compact will outline ways in which the parents, school staff, and students will work together to ensure high student academic

achievement. The compact will be reviewed and discussed during fall parent-teacher conferences. Revisions will be made based on the Parent Survey results and additional suggestions provided by parents and other key stakeholders.

Linwood Public Charter School will provide frequent reports to parents on their children's progress through:

- a. Report Cards (October, January, March, and May)
- b. Progress reports in the middle of each term
- a. Parent Teacher Conferences (fall term and spring term). Additional conferences available upon request

Linwood Public Charter School will afford parents reasonable access to staff. The school has an open-door policy for parents with both administration and staff. Parents will be encouraged to volunteer (chaperones for field trips), participate (Parent Advisory Committee P.A.C.), and observe in their child's classroom (note: room observations are requested by parents and approved by school administrators). If requested by parents, the school will provide them opportunities for regular meetings to formulate suggestions (both written or verbal), to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.

Part IV: Building Capacity for Involvement

Linwood Public Charter School will ensure the effective involvement of parents and the community to improve student academic achievement. To foster positive parent and family engagement the school will:

- a. assist parents in understanding state and local academic standards and assessments during fall and spring Parent Teacher Conferences. The school will share local assessment information with parents via conferences/report cards/IEPs. Students receiving interventions will be progress monitored on a 6-week basis depending on the student's needs, and information will be shared with parents when appropriate. Grades, attendance, and behavior infractions will be available via JCampus and Class DOJO.
- b. provide materials and training to help parents to work with their children to improve achievement. The school will open a parent resource center. The purpose of the center is to assist parents and families to become active participants in their child's education. The center will offer various pieces of training, such as literacy, technology, parenting, and other strategies and skills. The school will also sponsor a yearly Port City Parent Expo. The expo will be a free event and will cover topics ranging from parenting strategies, family law, mental health, and personal finance.
- c. educate teachers, principals, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school. Staff will attend workshops and implement new ideas for effective parent communication.
- d. coordinate and integrate parent involvement programs and activities with local Head Start sites, Early Steps, childcare centers, home childcare programs, public preschools, and other programs. The school will use the parent resource center to encourage and support parent participation.
- e. ensure that information related to school and parent programs, meetings, and other activities are sent to the parents of participating children in a format and, to the extent practicable, in a language the parents can understand.

Part V: Accessibility

Linwood Public Charter School will provide parent involvement activities accessible to all parents, including economicallydisadvantaged, those with disabilities, limited literacy, parents who use English as their second language or are of any racial or ethnic minority background. Accessibilities include but are not limited to providing handicapped accessible facilities, transportation assistance, home visits, translation in a language parents can understand, bilingual interpreter, accommodations for hearing impaired parents, etc.
